Step 1: Complete all sections of the attached Securities Transfer Form.

For reasons of confidentiality, your broker cannot disclose your name. Please complete the "Donor Information" section and include your telephone number with the area code. Your advisor or broker will provide the CUSIP number (identification number) to be used as a reference for tracking purposes.

Step 2: Inform the Quebec Cancer Foundation of the pending transfer

Please fax a copy of the completed Securities Transfer Form to the Quebec Cancer Foundation. This step is important for the Foundation, since the shares will be transferred to our bank account anonymously. We will need your full contact information to be able to issue a tax receipt.
